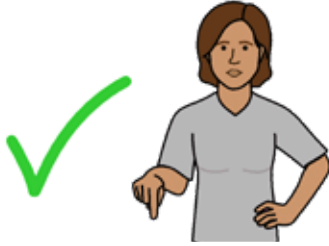

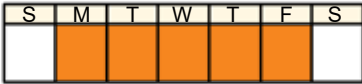

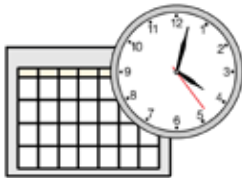
What we will do



We will try to fix the problem straight away.



If we **cannot** fix the problem straight away we will try to fix it in 5 business days.



We will tell you if we need more time.



We will give you reasons for our decision about your complaint.



If we **cannot** fix the problem we will

- tell you why

and

- see what we can do to help you.

Help to make a complaint



You can get help to make a complaint.



You can ask someone you trust to help you.

For example, family or a friend.



You can ask a **financial counsellor** to help you.



A financial counsellor knows how to help you if you have problems with your money.



You can ask a **lawyer** to help you.



A lawyer helps people with questions or problems with the law.



You might need to pay to talk to a lawyer.



You can use an **interpreter**.

An interpreter gives your message from one language to another.

For example

- English to Auslan

or

- English to Chinese or Spanish.



If you do **not** speak English you can call us and ask for an interpreter.

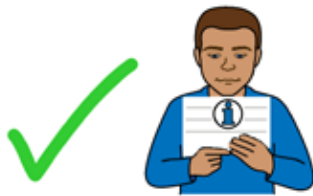

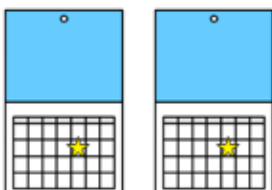

- **not** part of St. George

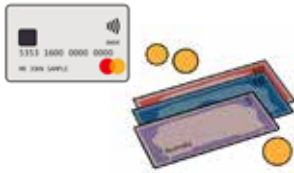
